Directions: From Fredericksburg, Stafford, and points north:

Rt 3 East towards King George

Left onto Rt 206 Dahlgren Road (stop light, Valero Gas Station on left corner) Then go 8.6 miles. Then turn right on Rt 218 Windsor Drive (cemetery on right corner) and cross over Rt 301 and go 2.1 miles to Left on Stillwater Lane (open field on left corner) and then bear Left on Shore Drive go thru open gate with "P" follow paved driveway past pool, house and continue on to sand driveway down to boat. You can't miss it.

From points South (Lancaster, Westmoreland, Richmond County, Northumberland): Take rt. 3 west to Oak Grove.

At the stoplight in Oak Grove, take a right onto Rt. 205 toward Colonial Beach. Follow rt. 205 past the town of Colonial Beach (or take Longfield rd. if you are familiar with it). After you leave the "town area" of Colonial Beach and pass Wilkerson's restaurant, travel @ 5 miles until you reach Rt. 218 at the Westmoreland/King George County line. Take a right onto 218 (there will be a "basket shop" on the left) and follow for @ 3 miles. Take a sharp left turn to continue on rt. 218 and follow for another few miles---crossing a small bridge over the Machodoc creek. A short distance after you cross the small bridge, turn right onto Stillwater Lane and then bear left onto Shore Drive (8018) as shown above.
