**OFFICIAL CALL FOR A MASS MEETING**

**WESTMORELAND COUNTY REPUBLICAN PARTY**

As Chairman of the Westmoreland County Republican Party, and pursuant to the Plan of Organization of the Republican Party of Virginia, and as recommended and directed by the Westmoreland County Republican Committee, I, Robert R. Fountain, do hereby issue this CALL for a Mass Meeting to be held in the District Courtroom, George D. English Building, 111 Polk Street, Montross, VA starting at 7:30 p.m. on Thursday, 25 March 2010, with registration starting at 7:00 p.m., for the following purposes:

a) Electing up to 12 Delegates and an equal number of Alternates to the First Congressional District Republican Convention to be held on Saturday 15 May 2010 at the Caroline County High School, 19155 Rogers Clark Highway, Milford, VA 22514 starting at 1:00 p.m., with registration beginning at 11:00 a.m. local time for the purposes of (1) electing a First District Chairman and (2) the transaction of such other business as may properly come before the Convention. Up to five (5) individuals may be elected for each Delegate and Alternate vote. (There will be no registration fee to participate in this Convention. A contribution of \$10.00 will be requested to defray the cost of the Convention. A photo ID will be required at the time of registration.)

b) Electing a Chairman, a Vice-Chairman, a Secretary and a Treasurer as officers plus six (6) Precinct Captains as members of a Committee to lead and conduct the affairs of the Westmoreland County Republican Party unit of the Republican Party of Virginia for the next two years.

c) Electing a Committee of up to 100 members, including not less than 10 members from each of the five election districts plus all elected Republican office holders from Westmoreland County as at large members, to serve as the Westmoreland County Republican Committee for the next two years.

d) For the transaction of such other business as may properly come before the Mass Meeting.

## QUALIFICATIONS FOR PARTICIPATION

All legal and qualified voters of Westmoreland County under the laws of the Commonwealth of Virginia, regardless of race, religion, sex or national origin, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing general election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

## FILING REQUIREMENT

Candidates for election as Delegates or Alternates to the First Congressional District Convention and/or as Officers or Precinct Captains of the Westmoreland County Republican Committee shall file a written statement, using the official pre-filing form, by mail or in person, with the Chairman of the Westmoreland County Republican Committee, RADM Robert R. Fountain, 4750 Zacata Road, Montross, VA 22520. Forms must be received not later than 5:00 p.m. on Friday 12 March 2010. Postmarks do not govern. Forms may be obtained by contacting the Chairman by mail, telephone (493-9522) or in person. There will be no filing fee required for any of these offices.

## REGISTRATION FEE

There will be no registration fee to participate in this Mass Meeting.
